Order : This petition coming on for orders upon perusing the petition filed in support thereof and upon hearing the arguments of MR.B.ANANDAN, Advocate for the petitioner and of MR.K.SUYAMBULINGA BHARATHI, Government Advocate(Crl. Side) on behalf of the Respondent, the court made the following order:-

This Court, by order dated 23.03.2020, in Crl.O.P.(MD)No.5010 of 2020, directed the petitioner to appear and execute a bond for a sum of Rs.10,000/- [Rupees Ten Thousand only] before the learned Judicial Magistrate, Pattukottai. According to the petitioner, due to lock down owing to COVID-19 pandemic situation, the petitioner was not able to arrange the sureties, within the time stipulated by this Court and hence, the present petition has been filed seeking extension of time.

2. Considering the facts and circumstances of the case, this Criminal Miscellaneous Petition is ordered and time granted by this Court vide order dated 23.03.2020 in Crl.O.P.(MD)No.5010 of 2020 is extended by two weeks from today, subject to payment of Rs.10,000/- [Rupees Ten Thousand only] to the credit of Karur
