For bail in crime no. 1119 of 2020 on the file of the respondent police

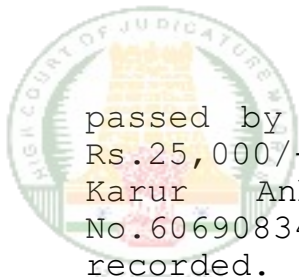
ORDER : The Court Made the following order :-
