Prayer in CRL MP (MD). NO. 4180 OF 2020 :-

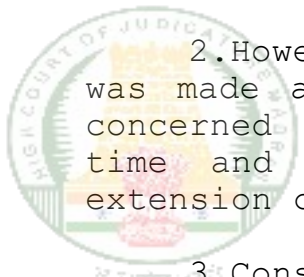

Earlier, this Court, by order dated 16.07.2020, in Crl.M.P. (MD).No.3170 of 2020 in Crl.O.P.(MD)No.6864 of 2016, extended the time to the petitioner to appear before the concerned Court within a period of 15 days from the date of receipt of that order.
