2. According to the learned Government Advocate(Crl.Side), the petitioner is complying with the conditions imposed by this Court regularly and the investigation is substantially completed.

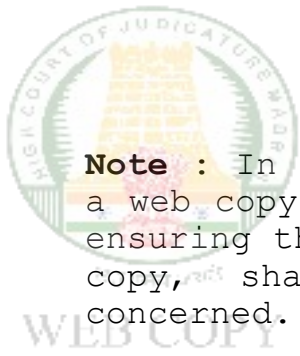
