Prayer: Writ petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to grant temporary licence in favour of the petitioner for taking out the excess sand (cghp kz;) available when levelling the upland lands comprised in Survey Nos.51/4, 5A, 52/1, 54/1, 54/2, 58/2, 58/3A, 60/1A to an extent of 3.38 Hectares situated at Chinna Pallipalayam Village, Thottiyam Taluk, Trichy District, on the basis of the petitioner's representation dated 29.07.2020 within time frame stipulated by this Court.

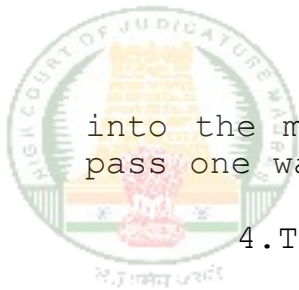
