Earlier, this Court, by order dated 23.07.2020, in Crl.M.P. (MD).No.3676 of 2020 in Crl.O.P.(MD)No.6657 of 2020, extended the time to the petitioner to deposit a sum of Rs.20,000/- (Rupees Twenty Thousand Only) by way of Demand Draft, in favour of 'The Dean, Thanjavur Medical College and Hospital. Thanjavur', on or before 07.07.2020.

2. However, according to the petitioner, he was affected by Covid-19 positive he was not able to comply the order, within the stipulated time and hence, the present petition has been filed seeking extension of time.
