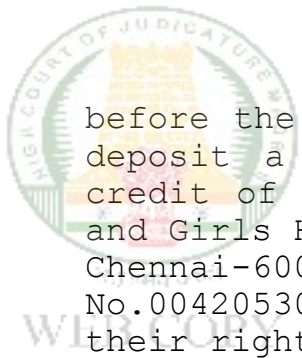
This petition has been filed to extend the time granted by this Court.

2. This Court, by an order dated 12.03.2020 in Crl.OP.(MD) No.4436 of 2020, directed the petitioners to appear before the learned Judicial Magistrate, Papanasam, Thanjavur District.

3. The learned counsel appearing for the petitioners would submit that due to pandemic situation they were not able to surrender the sureties before the learned Judicial Magistrate, Papanasam, Thanjavur District, within the prescribed time.

4. Heard the learned Government Advocate (criminal side) appearing for the respondent police.

5. Considering the facts and circumstances, time is extended by two weeks from today and the petitioners are directed to surrender



before the Court below on or before **18.09.2020** and also directed to deposit a sum of Rs.5,000/- (Rupees Five Thousand Only) to the credit of the Missionaries of Charity Nirmala Shishu Bhavan, (Boys and Girls Home), No.26/79, West Madha Church Road, Royapuram, Chennai-600 013 (South Indian Bank, George Town, Saving Account No.0042053000009382, IFSC Code: SIBL0000042) without prejudice to their rights and contention before the trial Court.
