PRAYER :-

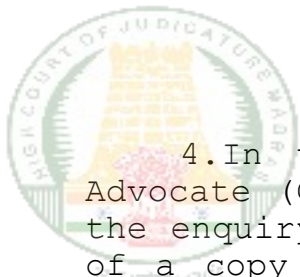
For Anticipatory Bail in Crime No. not known of 2020 on the

the learned Government Advocate (Crl.Side) appearing for the

3. When the matter is taken up for hearing, the learned
Government Advocate (Crl. Side) appearing for the respondent Police
submitted that petition enquiry is pending against the petitioner.



4. In view of the submission made by the learned Government Advocate (Crl. Side), the respondent Police is directed to complete the enquiry, within a period of four weeks from the date of receipt of a copy of this order and if any prima facie case is made out against the petitioner, the respondent police shall register the First Information Report. Till then, the respondent police is directed not to arrest the petitioner.

5. Accordingly, this criminal original petition is closed.
