PRAYER :-

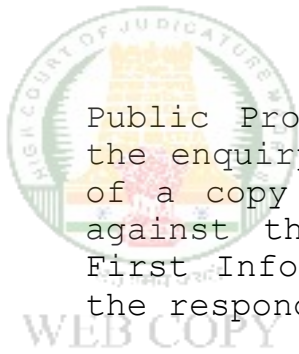
For Anticipatory Bail in Crime No. not known of 2020 on the file of the Respondent Police

ORDER : The Court made the following order :-

The petitioners/accused apprehending arrest at the hands of the respondent Police for the offence punishable under Sections 498(A) of IPC, seek anticipatory bail.

2.When the matter is taken up for hearing, the learned Additional Public Prosecutor appearing for the respondent Police submitted that petition enquiry is pending against the petitioners.

3.In view of the submission made by the learned Additional



Public Prosecutor , the respondent Police is directed to complete the enquiry, within a period of four weeks from the date of receipt of a copy of this order and if any *prima facie* case is made out against the petitioner, the respondent police shall register the First Information Report or close the petition enquiry. Till then, the respondent police is directed not to arrest the petitioners.

4. Accordingly, this criminal original petition is closed.
