completed and filed final report and the same was taken cognizance in P.R.C.No.16 of 2020, on the file of the learned Judicial Magistrate No.II, Kumbakonam.

5. Considering the fact that the petitioners are regularly complying with the conditional order, the condition already imposed on the petitioners is relaxed and the petitioners shall report before the respondent police as and when required for interrogation.
