This petition has been filed to extend the time granted by this Court.

2.This Court, by an order dated 14.08.2020 in Crl.M.P.(MD) No.3905 of 2020 in Crl.OP.(MD)No.5080 of 2020, granted two weeks time to execute the sureties before the concerned Court and deposit of Rs.10,000/- to the Credit of Madras High Court Madurai Bench Advocate Clerk's Welfare Association, Madurai.
