3. The learned counsel appearing for the petitioner would submit that due to pandemic situation he was not able to surrender the sureties before the learned Judicial Magistrate No.I, Virudhunagar, within the prescribed time. Hence, he seeks extension of time to surrender the sureties before the concerned Court.

4.Heard the learned Government Advocate (criminal side) appearing for the respondent police.

Considering the facts and circumstances, time is extended by Two weeks from today and the petitioners are directed to surrender before the Court below on or before **17.09.2020** and also directed to deposit a sum of Rs.5,000/- (Rupees Five Thousand Only) to the credit of the Missionaries of Charity Nirmala Shishu Bhavan, (Boys and Girls Home), No.26/79, West Madha Church Road, Royapuram, Chennai-600 013 (South Indian Bank, George Town, Saving Account No.0042053000009382, IFSC Code: SIBL0000042) without prejudice to his rights and contention before the trial Court.
