the Constitution of India, is not meant for clubbing various issues or different variety of orders passed by the different authorities in one single writ petition and therefore, the present prayer in this writ miscellaneous petition, to permit the petitioners to join together and file a single writ petition, cannot be entertained.

4. In view of the same, this Writ Miscellaneous Petition is rejected. It is open to the petitioners to file separate writ petitions challenging the respective impugned orders passed by the respective authorities/respondents.”

3. When the matter was taken up for hearing today, the learned counsel appearing for the petitioners seeks permission of this Court to withdraw this Writ Miscellaneous Petition and has also made an endorsement to that effect.
