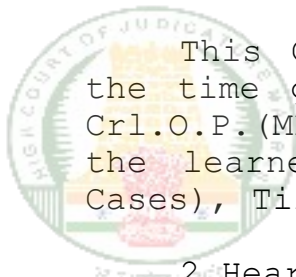
Prayer in CRL MP (MD) NO. 4348 OF 2020 :-
