This habeas corpus petition has been filed by the detenu, namely, Gowrisankar, son of Srinivasan, aged about 32 years, challenging the detention order in C.No.19/Detention/C.P.O/T.C/2020,



dated 24.07.2020 passed by the second respondent, branding him as "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982.

When the matter is taken up for hearing, the learned counsel for the petitioner as well as the learned Additional Public Prosecutor appearing for the respondents, by producing a copy of G.O.Rt.No.3718, Home, Prohibition & Excise (XII) Department, dated 07.09.2020, would state that the impugned detention order has been revoked.
