PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :- For Anticipatory Bail in crime No. 18 of 2020 on the
file of the respondent police

ORDER : The Court made the following order :-

The petitioner is a sole accused apprehending arrest at the hands of the respondent police for the offences punishable under sections 498A of I.P.C. And Section 4 of DP At, 1961, in Crime No. 18 of 2020 on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that the petitioner is a sole accused and the defacto complainant is wife of the petitioner herein and they are having one male child. Due to matrimonial dispute between the parties, the petitioner has filed a petition in HMOP No.57 of 2020 for divorce before the Subordinate Court, Manapparai the same is pending. The petitioner herein has demanded more dowry from the defacto complainant and sent back to her parental home and the petitioner has arranged second marriage. Hence, the present complaint has been lodged by the defacto complainant.

3. Heard the learned counsel appearing for the petitioner and the learned Government Advocate(Crl. Side) appearing for the respondent.



4. The learned counsel appearing for the petitioner would submit that he did not commit any offence as alleged by the prosecution and the petitioner is innocent person and he has been falsely implicated in this case. Hence, he seeks anticipatory bail.

5. The learned Government Advocate (Crl. Side) appearing for the respondent police, on instructions, submitted that HMOP proceedings is pending between the parties.

6. Considering the facts and circumstances of the case and considering the fact that matrimonial dispute is pending between the parties, this Court is inclined to grant anticipatory bail to the petitioner with certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance before the learned Judicial Magistrate, Manapparai, Trichy District, and on his executing a bond for a sum of Rs.25,000/- (Rupees Twenty Five Thousand only) with two sureties each for a like sum to the satisfaction of the learned Magistrate concerned and on further condition that,

(a) the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

(b) the petitioner shall report before the respondent police daily at 10.30 a.m., without fail for a period of Two weeks and thereafter, as and when required for interrogation.

(c) the petitioner shall not tamper with evidence or witness either during investigation or trial;

(d) the petitioner shall not abscond either during investigation or trial;

(e) on breach of any of the aforesaid conditions, the learned Magistrate/ Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]; and;

(f) if the accused/petitioner thereafter absconds, a fresh FIR can be registered under Section 229-A IPC.
