2. This Court, by an order dated 24.07.2020 in Crl.OP.(MD) No.7577 of 2020, granted anticipatory bail to the petitioners on condition that the petitioners shall report before the respondent police once in a week i.e., on every Monday at 10.30 a.m., until further orders.

3. Heard the learned counsel for the petitioners and the learned Government Advocate (criminal side).

4. According to the learned Government Advocate (criminal side) the petitioners are complying with the conditions imposed by this Court regularly and the investigation is substantially completed.



5. Considering the fact that the petitioners are regularly complying with the conditional order, the condition already imposed on the petitioners are relaxed and the petitioners shall report before the respondent police as and when required for interrogation.
