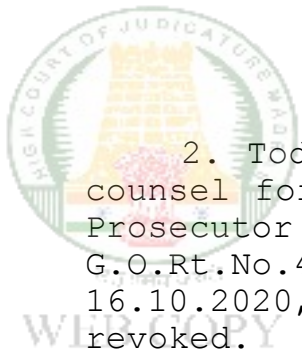

This habeas corpus petition has been filed to quash the proceedings of the second respondent in M.H.S.Confdl No.42/2020 dated 12.08.2020, branding the detenu, the petitioner, namely, Highcourtraja, male, aged about 33 years, S/o Ramakrishnan, as a "Goonda" as contemplated under Section 2(f) of Tamil Nadu Act, 14 of 1982, detained him at the Central Prison, Palayamkottai, and to set him at liberty.
