The Criminal Original Petition has been filed seeking the relief to call for entire records in connection with Crime No.81 of 2020 dated 21.02.2020 pending on the file of the first respondent and quash the same as illegal.

2.Today, when the petition is taken up for hearing, the learned Government Advocate (Crl.Side) appearing for the first respondent, on instructions, would submit that in respect of Crime No.81 of 2020, the first respondent police completed the investigation and prepared a final report on 06.07.2020. In this regard, he has produced a copy of the final report prepared by the first respondent.

3.Now on go through copy of the final report filed by the first respondent, it appears that before closing the investigation, the

first respondent examined 11 witnesses as L.W.1 to L.W.11 and recorded their statements. Therefore, in the said circumstances, the prayer sought for by the petitioner become infructuous.
