PETITION FOR BAIL Under Sec.439 of Cr.P.C.

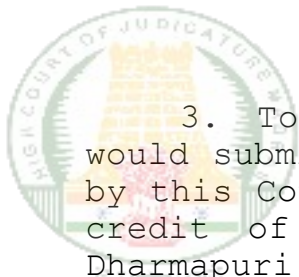
PRAYER :-
