3. Heard the learned counsel for the petitioners and the learned Government Advocate (criminal side) for the respondent police.

4. According to the learned Government Advocate (criminal side), the petitioners are complying with the conditions imposed by this Court regularly from 20.08.2020 and the investigation is substantially completed.

5. Considering the fact that the petitioners are regularly complying with the conditional order, the condition already imposed on the petitioners is relaxed and the petitioners shall report before the respondent police as and when required for interrogation.
