2.Giving liberty to the petitioners to question the said orders, these writ petitions stand closed. No costs. Consequently, connected miscellaneous petitions are closed.

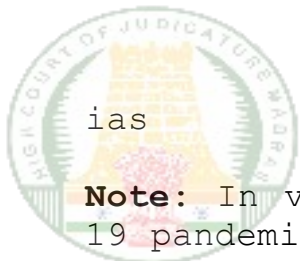
