Common Prayer: These Writ petitions have been filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondent to give effect to the order of the Appellate Deputy Commissioner (ST)(FAC), Madurai (North), Madurai passed in Appeal Nos. & Year- 44/2014 (TNVAT) and 45/2014 (TNVAT) dated 16.11.2017 relating to the assessment years 2007-08 and 2008-09 and consequently issue Refund Voucher for the excess taxes to the petitioner as per Rule 14(18) of the Tamil Nadu Value Added Tax Rules, 2007 together with interest @ 6% per annum as per Section 42(5) of the Tamil Nadu Value Added Tax Act, 2006.

Heard the learned counsel on either side. By consent of both parties, these writ petitions are taken up for final disposal at the admission stage itself.

2.The same assessee had filed these two writ petitions in respect of two different assessment years.It is not in dispute that the assessee had succeeded before the appellate authority. It is also stated that the order passed by the appellate authority had become final. Therefore, the respondent is obliged to give effect to the same. Section 42(5) of the Tamil Nadu Value Added Tax Act, 2006 stipulates that.

3. Therefore, the respondent is directed to give effect to the order granted in favour of the writ petitioner and also make



the consequent refund along with interest @ statutory rate. The respondent is given eight (8) weeks time to comply with this direction.

4. These writ petitions are allowed, accordingly. No costs.
