2.The learned counsel for the petitioner would submit that earlier this Court by an order dated 06.08.2020 granted anticipatory bail to the petitioner with a condition to deposit a sum of Rs.10,000/- (Rupees Ten thousand only) to the credit of Madras High Court Madurai Bench, Advocate Clerk's Welfare Association, Madurai-625 023, within a period of four weeks from the date of receipt of copy of that order. Due to lock down owing to COVID-19 pandemic situation the petitioner is not able to deposit the amount within the time prescribed by this Court and hence, the present petition has been filed seeking extension of time.



3. Considering the request, time granted by this Court vide order dated 06.08.2020 in Crl.O.P(MD) No.8226 of 2020 is extended by two weeks from today.
