This Court, by order dated 11.06.2020 in Crl.O.P.(MD)No.5920 of 2020, directed the petitioners to appear and execute a bond for a sum of Rs.10,000/- [Rupees Ten Thousand only] before the Judicial Magistrate Court, Thiruvaiyaru, within a period of eight weeks. According to the petitioners, due to lock down owing to COVID-19 pandemic situation, the petitioners were not able to appear before the Magistrate concerned, within the stipulated time and hence, the present petition has been filed seeking extension of time.
