2.The learned counsel for the petitioners would submit that earlier this Court by an order, dated 11.06.2020 granted anticipatory bail to the petitioners on condition to surrender before the concerned Court within a period of eight weeks. Due to lock down owing to COVID-19 pandemic situation, the petitioners are not in a position to appear before the concerned Court and produce the sureties and hence, the present petition has been filed seeking extension of time.



3. Considering the request, time granted by this Court vide order dated 11.06.2020 in CrI.O.P(MD) No.5927 of 2020 is extended by two weeks from today.
