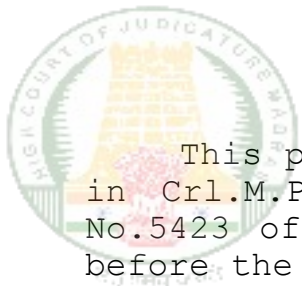
Prayer in Crl.M.P.(MD).4623 of 2020:-

Petition is filed under section 482 of Cr.P.C., to extend the time limit for surrender before the learned III Additional District Court PCR, Madurai by order in Crl.O.P.(MD).5423 of 2020.

Prayer in CRL OP(MD) . No.5423 of 2020:

Petition is filed under section 482 of Criminal Procedure, to direct the Special Sessions Judge for Scheduled Caste and Scheduled Tribes)Prevention of Atrocities) Act, 1989, Madurai, to accept the surrender of the petitioner/Accused No.3 and consider the petitioner's bail application and grant bail on the date of surrender itself in Crime No.30 of 2020, dated 14/02/2020 on the file of the Respondent No.2.
