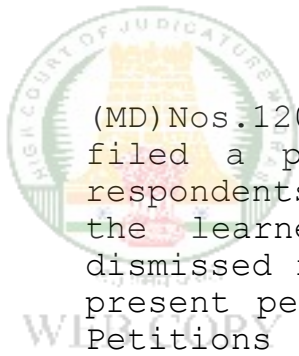

Against the same, the present petitions have been filed to restore the Criminal Original Petitions and to condone the delay of 672 days in filing the petitions.

2.Today, when the matter came up for hearing, the learned Additional Government Pleader appearing for the respondents would submit that already private complaints filed by the respondent/petitioner herein were dismissed as withdrawn by order, dated 14.06.2019 on the file of the learned Additional District Munsif Cum Judicial Magistrate, Vendasandur.
