Prayer in WP(MD). 26990 of 2019 :

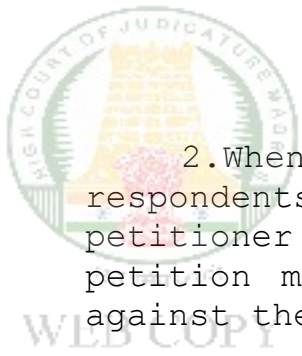
