2.Recording the endorsement made by the learned counsel appearing for the petitioners, the Criminal Miscellaneous Petition is dismissed as withdrawn.

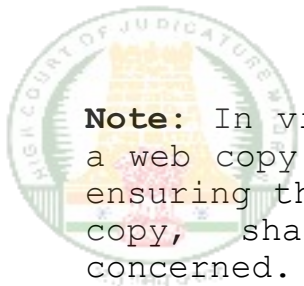
