This Habeas Corpus Petition has been filed praying for issuance of Writ of Habeas Corpus directing the respondents 1 to 3 to produce the petitioner's daughter namely Miss.Karpagalakshmi, aged about 17 years before this Court and to hand over the custody to the petitioner.

2.It is the case of the petitioner that the detainee was missing from 07.09.2020 and despite lodging a complaint and



registration of the case in Crime No.358 of 2020, no action was taken.

3. When the petition is taken up for hearing, the petitioner and his daughter, the detenu Karpagalakshmi appeared before this Court through Video Conferencing and the detenu has stated that she is ready to go with her father, the petitioner herein. In turn, the petitioner has also informed this Court that he is willing to take the detenu with him.

4. In the light of the above fact, we are of the opinion that no further order is necessary in this petition and hence, this Habeas Corpus Petition is closed.
