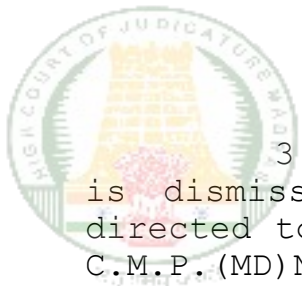
Prayer in SA(MD).507/2017 :
