3. According to the learned Government Advocate (Criminal Side), the petitioner is complying with the condition imposed by this Court regularly.

4. Considering the fact that the petitioner is regularly complying with the conditional order, the condition already imposed on the petitioner is, hereby, modified to the effect that the



petitioner shall report before the respondent police once in a week, i.e., on every Monday at 10.30 a.m., until further orders.

5. This Criminal Miscellaneous Petition is ordered accordingly.
