ORDER

This Writ Petition is filed to direct the 2nd respondent to consider the petitioner's representation dated 29.11.2018, in pursuance to the communication of the 1st respondent in Na.Ka.A2/14475/2018 dated 12.12.2018.

2.According to the petitioner, he made a representation dated 29.11.2018, to the 1st respondent seeking to demarcate the petition mentioned property and though the 1st respondent, by proceedings dated 12.12.2018, had forwarded the said representation to the 2nd respondent to pass appropriate orders, so far, no action has been taken. 5.This Writ Petition is disposed of, with the above direction. No costs.
