This Court, by order dated 12.06.2020, in Crl.O.P.(MD)No.6148 of 2020, directed the petitioners to appear before the learned Judicial Magistrate No.I, Madurai, with two sureties, within a period of eight weeks from the date on which the order copy was made ready. According to the petitioners, due to lock down owing to COVID-19 pandemic situation, the petitioners were unable to execute the sureties, within the stipulated time and hence, the present petition has been filed seeking extension of time.
