This petition is filed to extend the time limit of the petitioner's surrender and execute sureties in Cr1.M.P.No.4135 of 2020 in Cr1.O.P(MD)No.5010 of 2020, dated 21.08.2020.

2. On perusal of record, it is seen that earlier this Court by an order dated 21.08.2020 in Cr1.M.P(MD) No.4135 of 2020 has extended two weeks time to comply with the condition from 21.08.2020 for payment of Rs.10,000/- to the credit of Karur Anbukarantal Society, failing which the petition shall stand dismissed automatically without any further reference to this Court.

3. This is the second extension petition and hence this Court is not inclined to grant further time to surrender before the concerned Court and execute sureties.



4. Hence this petition stands dismissed.
