ORDER

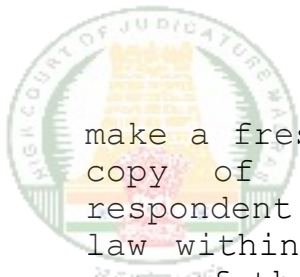

make a fresh representation to the concerned authority enclosing the copy of this order. On receipt of such representation, the respondent shall consider the same on merits and in accordance with law within a period of eight weeks from the date of receipt of a copy of this order. No costs.
