Prayer CRL MP(MD) . No.4910 of 2020 :- This Criminal Miscellaneous Petition filed under Section 482 of Cr.P.C. Praying this court, to extend time for 2 weeks period to surrender before the 1st Additional District and Sessions Judge, Trichy(PCR Act Cases) and apply for bail in Crime No.78 of 2020 in CrI.O.P. "Heard, the learned counsel appearing for the petitioner and Mr.V.Neelakandan, learned Additional Public Prosecutor appearing for the respondents 1 and 2.

2. The learned counsel appearing for the petitioner states that on account of viral fever and subsequent lock down, he could not appear before the Special Court and apply for regular bail. He, therefore, seeks extension of time.

3. The Petitioner is given two more weeks from the date of receipt of a copy of this order to surrender before the court below and applied for regular bail. The Jurisdictional Court will dispose of the petitioner's bail petition on merits and in accordance with law on the same day of surrender.

4. This Criminal Miscellaneous Petition stands allowed.
