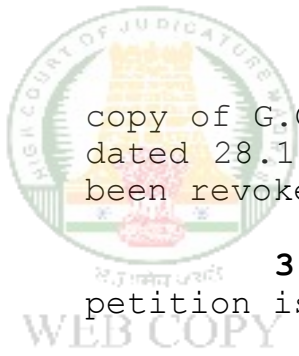

This habeas corpus petition has been filed by the wife of the detenu, namely, Murugesan, son of Chellappa, aged about 32 years, challenging the detention order in M.H.S.Confdl No.63/2020 dated 14.09.2020, passed by the second respondent, branding him as "Drug Offender" as contemplated under Section 2(e) of Tamil Nadu Act 14 of 1982.

2. When the matter was taken up for hearing, the learned Additional Public Prosecutor for the respondents, by producing a



copy of G.O.Rt.No.4646, Home, Prohibition & Excise (XIV) Department, dated 28.10.2020, would state that the impugned detention order has been revoked.

3. Recording the above submissions, the habeas corpus petition is closed.
