For R-1 and R-2 : Mr.R.Erottuchamy

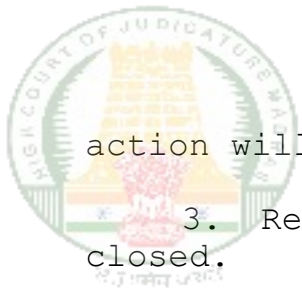
