ORDER

4.Mr.K.Sathya Singh, learned Additional Government Pleader appearing for the respondents would submit that the petitioner's representation dated 19.10.2019, will be disposed of by the 2nd respondent on merits and in accordance with law, within a period of three months.

Recording the submission made by the learned Additional Government Pleader and in view of the lapse on the part of the respondents on considering the petitioner's representation, this Court directs the 2nd respondent to conclude and pass final orders on the disciplinary proceedings initiated as against the petitioner vide charge memo No.4444/A1/2018 dated 19.09.2018, by considering the petitioner's representation dated 19.10.2019 on merits and in accordance with law, within a period of three months from the date of receipt of a copy of this order.

6. With the above direction, the Writ Petition stands disposed of. No costs.
