Ltd., Chennai.

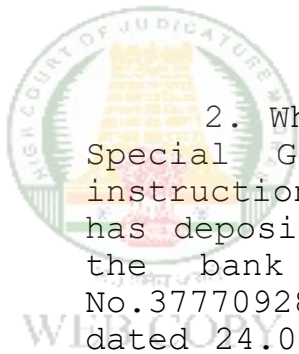
