2.The second respondent / defacto complainant as well as the petitioner/accused No.5 are present before this Court through video conference and they are identified by their respective learned counsels and both the parties have filed a joint compromise memo stating that the matter in issue between them has been amicably resolved and therefore, the second respondent / defacto complainant is not willing to prosecute the case and therefore, would pray for quashing the F.I.R. in Crime No.1188 of 2019.
