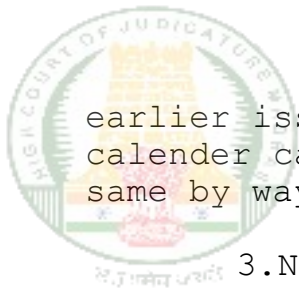

2.The petitioner is the complainant in C.C.No.35 of 2018 on the file of the learned Judicial Magistrate, Fast Track Court (Magisterial Level), Thoothukudi. It is a case arising under Section 138 of Negotiable Instruments Act. The third respondent herein is figuring as the sole accused in the said complaint. The petitioner's counsel points out that the third respondent has now been arrested in connection with Crime No.1529 of 2020 on the file of second respondent. He is presently remanded to custody.
