Prayer in CRL. M.P. (MD) 5217 of 2020:-

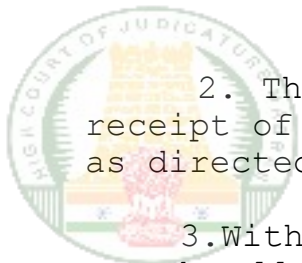
