3.Considering the reasons stated in the petition, this petition is ordered and the time for surrender by the petitioners before the concerned Court and executing the sureties is extended by two weeks from the date of receipt of a copy of this order, on condition to deposit a sum of Rs.10000/- (Rupees Ten Thousand only) as costs to the Hon'ble Chief Justice relief fund, failing which, the anticipatory bail already granted by this Court shall stand cancelled.



4. Accordingly, this Criminal Miscellaneous Petition is allowed.
