PRAYER : This Writ Petition is filed under Article 226 of Constitution of India for issuance of Writ of Certiorarified Mandamus, to call for the records on the file of the first respondent in connection with the impugned seniority panel issued in Na.Ka.No.A3/8819/2020 dated 05.10.2020 and consequential impugned promotional panel issued by him in A3/8819/2020 dated 08.10.2020 quash the both as illegal and arbitrary and consequently, direct the first respondent to revise the seniority and include the petitioner's name immediately before Sl.No.24 Mr.K.Singaravelu in promotional panel and thereby promote her to the post of High School Headmistress with all service benefits on par with her batch mates within the time limit that may be stipulated by this Court.
