Taking note of the pendency of the representation dated 28.09.2020 and considering the submissions of the learned counsel, this Court directs the second respondent to dispose of the representation, dated 28.09.2020, on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order.
