2. Heard the learned Counsel appearing for the petitioners.

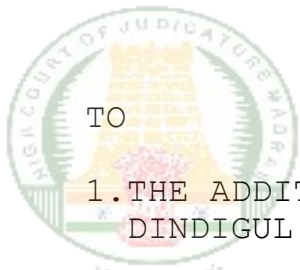
