Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents to revise the pay of the petitioner with effect from 1.1.2016 notionally and to pay difference in salary with implement from 1.10.2017 and to pay the difference in gratuity, difference in earned leave salary, difference in commutation and difference in pension with effect from the date of retirement of the petitioner together with interest at the rate of 18 percentage p.a in terms of 7th pay commission recommendations for revision of pay as per G.O.Ms.no.134, Transport(D) dept dt 9.4.2018, within the time frame that may be stipulated by this Court.
